HB 1	Passed House, Now HSS then JUD	1/18/12	Policy for securing Health Care Services	Rep. Gotto, Rep. Lynn	This bill creates a public policy that allows a person to choose or decline any type of health care services.
HB 11	L&C then FIN	1/18/12	Colonoscopy: public employee retirees	Rep. Gara	This bill requires the retiree health insurance coverage offered by the state and by certain local governments include coverage for colorectal screening, including colonoscopies

Wilson	Provides statutory basis for the administration of a dedicated transportation endowment fund created by a constitutional amendment to receive income from the motor fuel tax, vehicle license fees, and other transportation-related receipts. The bill takes effective only if voters approve the amendment to the Alaska Constitution proposed in HCR 4.

Guttenberg	Prohibits "covered facilities," which would include most health care facilities that receive any federal money, from purchasing prescription drugs at prices higher than set under a federally-authorized drug discount pricing plan; directs HSS to study whether participation in such a plan should be made mandatory.
HB 43	HSS then FIN	1/18/12	Prescriptions and Generic Drugs	Rep. Guttenberg	This bill requires pharmacists to substitute generic and therapeutically equivalent drugs approved by HSS as most cost effective unless a prescription indicates it must be dispensed as written. Provisions do not apply to a hospital or other institution that has established a formulary system. Requires HSS to approve and maintain a list of prescription drugs with more cost effective and therapeutically equivalent generics than their brand-name equivalents.

The bill creates a Transportation Infrastructure Fund Advisory Council to make annual recommendations to the legislature for fund expenditures.
