

**Residential Supported Living Services:** Providers of this service may choose to be reimbursed according to the methodology described under Direct Cost/A&G Rate Methodology, if approved by the Division of Senior and Disabilities Services (DSDS), or the fixed daily service rates described below:

**PLEASE NOTE:** These rates are for the residential supported living (RSL) services provided to a resident in a state licensed, certified, enrolled assisted living home and the resident is individually enrolled in CHOICES for the Elderly or CHOICES for Adults with Physical Disabilities Medicaid Waiver Programs. RSL service will be indicated in the resident's Medicaid waiver plan of care. Medicaid does not reimburse for basic board and room. Each assisted living provider must bill the client for room and board costs, and maintain financial records documenting client billings and payments. Basic room and board can be paid directly to the assisted living provider from a client's resources, by family and/or from other sources.
